

Medix Dental IT March Madness DDS Challenge 2023 Official Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW. THE FOLLOWING CONTEST IS INTENDED FOR VIEWING IN THE UNITED STATES, THE DISTRICT OF COLUMBIA AND CANADA ONLY (EXCLUDING PUERTO RICO, OTHER U.S. TERRITORIES AND FOREIGN TERRITORIES) AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. DO NOT PROCEED WITH THIS CONTEST IF YOU ARE NOT LOCATED IN THE UNITED STATES OR THE DISTRICT OF COLUMBIA.

- 1. ELIGIBILITY.** Medix Dental IT “March Madness DDS Challenge Group” (the “Contest”) is only open to entrants who, as of the entry date, are permanent legal residents of the “United States” (the “Territory”) and at least eighteen (18) years of age. The Contest is void outside of the Territory listed herein and where prohibited or restricted by law. The Contest, and any website pages and advertisements related thereto, is intended for viewing only within the eligible Contest Territory, and entrants must be present in the eligible Contest Territory at the time they enter.

Proof of submission will not be deemed to be proof of receipt by Medix. Any submission that does not comply with any aspect of these Official Rules may be rejected by Medix and the entrant disqualified. Potential winners may be required to show proof of being the authorized entrant. To be an authorized contestant you must be employed by a Medix Dental IT partner.
